## Clear Lake Board Meeting March 21, 2018

\$3,174.71 will be reimbursed through SID. The ending balance in the checking account is \$16,454.08. We have \$5,550.00 in outstanding association dues. The Pinnacle account has an ending balance of \$11,113.07.

## **Discussion Items:**

• Report from Rob Hoffpar: Fluoridone (generic brand of Sonar) is the only effective chemical treatment for rooted plants and pond weeds. If we do not apply a second treatment of Fluoridone this year we may see some residual treatment results but the plant regrowth will return later in the summer. Fluoridone is not harmful to fish, pets or humans. Cost for Fluoridone treatment is \$7,900.

Chara is not a root plant. It is a type of algae that you have to treat every year. Granular Cutrine Plus is the treatment for chara. The surface temp of the water must be 65 degrees before Cutrine can be applied. Cutrine does not harm fish, pets or humans. Cost for Cutrine treatment is \$300.

The goal of aeration is to turn over the water at the bottom of the lake. If the aerator compressor is not strong enough we are only pushing nutrients up to the top of the lake. An aerator with three diffusers is needed for our size of lake.

We need 10 grass carp per acre to control the chara. 25 grass carp were added in 2017 and 20 were added in 2015.

A motion was made by Jackie and seconded by Rob to approve the Fluoridone treatment and Cutrine treatment for a total cost of \$8,200.

A motion was made by Rob and seconded by Shirl to add an additional 25 grass carp to the lake.

• The spring clean-up day is scheduled for April 21<sup>st</sup>. Work will begin at 9:00. Shirl will create a list of jobs that need to be done. Shirl has also created a mowing schedule for the shelter lot. The mowing schedule begins on April 28<sup>th</sup>.

A motion was made by Jackie and seconded by Rob to adjourn the meeting at 9:10 p.m. The next meeting is scheduled for 7:00 p.m. on April 17<sup>th</sup> at Shirl's house.
