Lift Station

John Csukker has been working with Obrist to get this taken care of. Obrist is waiting for the parts and then we will proceed. Still waiting for parts. We were able to secure a loan from Pinnacle Bank for \$40,000. So as soon as Obrist can get started, we can start to proceed. Shirl and Lori signed on behalf of the Association as "members" in the event that they moved or are no longer on the board, it will not be tied to them.

Marsha and Kris expressed their concern that this was not voted on by the Board. Shirl explained that the SID Board saw a need to proceed quickly as Obrist is "loaning" us a pump. Shirl also explained this is only a line of credit right now and when the project is finished we will know more on amount needed. This can be discussed then as to how we should proceed as to paying back the loan. Shirl and Lori will keep us all informed when they know more.

Jackie made a motion to proceed with information and wait until a true dollar amount is known and then how to pay back loan if needed. Kris 2nd the motion.

Website

Krafka tree

Pam Krafka asked the board for permission to have Justin remove a tree in the cove area. He will do this after the lake has frozen. Board gave the go ahead. This was not done before the thaw. Need to address and see what can be done.

Cove Discussion

The Board decided that a committee needs to be put together. Several people at the meeting said they will help. Items such as the steps replaced, new or move rock, fixing the wooded posts and cleaning up bank. The fire hydrant pipe also needs to be clear from debris. DJ Brandenburg has some block he is not using so possibly purchase these from him and figure out the next step. The idea of hiring Chase Jaster to spear head part of this was also mentioned.

Looking into lot lines in that area was mentioned. Les said Terry Fisher has a metal detector and perhaps he can find the pins. Or hire a surveyor could be a step.

Need to get information and during walk around discuss this further. Also she would like to look into the idea of putting lines on the tennis court for a pickleball

court.

Sprinklers

Now that the sprinklers have all been fixed we need to work on maintaining them. We will look in the spring on assigning certain people to handle each box or whatever

Well - hand pump

Commons area/Speicher

Lori stated Alan Speicher will replace any white rock that was messed up during his construction project by the commons area.

Connie Perry attended meeting in regards to drainage issues she has in her garages. Discussion of corner by Connie Perry as rock was hit and moved a few times in the past

Lori will get in contact with Connie to see if there has been any progress on this.

Clear Lake Sign - Kris had cut some branches to help with this but feels it still is not

This needs to be looked at before more is done or perhaps look into this in the spring. No clear decision was made on how to handle this.

Stocking of fish done in November - 200 4-6" Walleye.

There was discussion on WHY only Walleye were received. There is concern that there is too many Bass. What other kind of fish would be good? Shirl will contact Rob to get any information from him. Also suggested we talk to the individuals that does a lot of the fishing here and possibly reestablish a fishing committee. Some of this will be tabled until spring.

This will be looked at in the future to see what other kinds of fish are available. Restocking of fish was voted on at the April 2021 meeting. However looking into different types of fish still needs to be addressed if there is concern.

Cut Trees - There are several branches that were cut at some point and need to be taken care of. With winter upon us some of this might have to wait until spring but it needs to get done.
