SID - Lift station

The lift station project seems to be working again. There are still a few glitches that John Csukker is taking care of. Will need to investigate getting a different controller. Perhaps on eBay. Also suggested using a different material for the panels as these new ones are already going bad. There also needs to be repairs/replacements to the lift station and the shack. The possibility of using synthetic parts was mentioned. Thoughts to build around it and add insulation. This will need to be addressed soon. John was unable to attend so Neal delivered information and answered questions.

Hand pump: John Csukker would like us to install a pump in the commons area for easier access to water. Information is that this is not a legal option.

There was discussion to raise the amount we give John Csukker. He does a lot and should be granted \$50 more per month. Kathy Kresha made a motion and Jim Speicher seconded the motion. Motion carried.

VYVE Broadband

After several underground sprinkler issues and other items, things seem to be working correctly. However – seems lines are not buried very deep so keep this in mind when doing yard work.

Budget Discussion and Approval: Shirl presented the budget and said things are basically on track as same as last year. It was voted to keep the lot assessment at \$500. Neal made the motion with Jeff Paige second. Motion carried.

A loan of \$60,000 was secured for the SID project with insurance, SID and other money used to make substantial payments. It is now roughly \$24,500.

New Business: Elections of Officers

Terry Norris and Pam Houdek terms end. Two board members needed to serve through 2027. Nominations were to keep them both on and Jim Speicher will be added as a member to the board. Neal Kratochvil made a motion and Juil Spencer seconded the motion. Motion carried.

Clean up day: Saturday, October 26.

The next major project concern is the road. We need to help take care of the road otherwise the possibility of an assessment would need to be considered.

Winter Gathering: Discussion to have a Christmas party in January. Places suggested were Isaac Walton, Eagles or Barrel House. Further discussion will be at the November meeting.
